15 ORDERED that the Debtors are hereby authorized to dispose of the Patient Records in  
16 the manner prescribed in Section 351 of the Bankruptcy Code and Rule 6011 of the Federal  
17 Rules of Bankruptcy Procedure and are authorized to publish a notice in the *West County*  
18 *Times* or in another appropriate newspaper regarding the disposal of the Patient Records; and  
19 it is further

20 ORDERED that this Court shall retain jurisdiction with respect to all matters relating to  
21 the interpretation or implementation of this Order.
